

This will help avoid errors when opening an account directly on the platform and ensure proper terminal setup.






2 In the top menu, select the "Downloads" tab

Step 1

After selecting "Download MT5 for Mobile Android", you will be redirected to Google Play.

Step 2

Click "Install".

Step 3

Once the installation is complete, click "Open".

Step 4

Accept the terms and conditions of the EULA, the Privacy Policy and data processing consent.

Step 5

A window titled

will appear – close it.


Step 6



Step 1

After selecting "Download MT5 for Windows", download the installation file.

Step 2

Open the downloaded file and allow the app to make changes to your device.

Step 3

Read and accept the license agreement, then click "Next".

Step 4

Wait for the installation to complete and click "Finish".

Step 5

A new window will open where you should:

- Verify that OnFin Ltd. is listed, then click "Next".
- Choose one of the options:
 - Connect to an existing trading account, if you already have one.
 - Open a real account, if you want to create a new trading account.
- Enter your **Login** (trading account number) and Password (from the trading account).
 - You can find your login details in the email "OnFin | Trading Account Opened".
- Ensure the server is set to OnFin-Live.

Step 6

Click "Finish".
